1. Roll Call

2. Approval of January 21, 2020 – Agenda

a. Motion by Bolton, second by Kolon to approve the January 21, 2020 agenda. **Motion carried by voice vote.**

3. Approval of December 17, 2019 Executive Committee Meeting Minutes

Motion by Sheehan, second by Hoffman to approve the December 17, 2019 meeting minutes.

4. Treasurer's Report

- a. The Treasurer's Report for the period Dec.1, 2019 –Dec. 31, 2019 was distributed and reviewed by Bolton. Revenue \$3,160.12- Expenses \$18,613.52 Balance to date: \$30,881.92. Motion by Bolton second by Kittredge to accept and file Dec. Treasurer's Report with clarification that Deposit Item GFWC Membership includes total memberships in December. Motion carried by voice vote.
- <u>b.</u> Review 2019 Budget Year End: Year End Total Revenue: \$87,812.00, Total Expenditures: \$107,284.57. Over budget due to video production, MJR ad, and insurance.

- <u>c.</u> 2019 Line Item Budget Adjustments: Motion by Bolton, second by Hoffman to approve the budget adjustment of \$35,889.03 as stated. **Motion carried by voice vote.**
- d. Approve Disbursements for Outstanding Bills: New bills reported Dec 18, 2019 Jan. 20, 2020: Katie Goplerud-Smith: Mileage Reimbursement RRWC \$358.23; Lenawee County Printing & Purchasing (postage & copier) \$21.34; Liberty Mutual Insurance electronic check \$750.00; Advantage Visuals \$992.50; First Federal Visa (TSN Annual Conference, FLG Annual meeting supplies/room rental, website domain renewals, t-shirts, EC meeting snacks) \$1,192.50: Total of \$3,314.57. <u>a.</u> David Rhoads – On behalf of the Friends of the Saline River: We maintain the Leslee Niethammer Saline River Preserve and help keep the river in the area clear. In 2019 they had 489 volunteer hours total and 134 river clearing volunteer hours. During various river clean-ups, 19 tons of debris was removed over a 2 mile stretch. They're restoring monarch butterfly habitat after confirming free shipment of various milkweed species from an organization. The Friends of the Saline River would volunteer to collect water samples if RRWC needed help in the area.

- c. Lenawee Lifelong Learners Program Marilyn Kremer explained the group would like RRWC to present Tuesday mornings in April about various water quality topics. Usually 10- 35 people attend. At Weber Center on Adrian Dominican Sisters Campus. 1st class is \$25, 2nd is \$10, the rest are free.
- d. The Stewardship Network Annual Conference Sybil briefed group about conference: Around 200 came, snowstorms were a problem. Great networking opportunities. Interesting presentation about an IL power co-op installing stewardship practices instead of cutting trees down every four years.

- e. RRWC internship opportunities Deciding if we do post an opportunity, it will be for local students instead of just targeting Eastern Michigan University.
- f. Loch Erin / Wolf Creek Management Plan Phil Kittredge, on Loch Erin Property Owners Association Board, briefed us on the webinar on Jan 23 that will cover EGLE's Nonpoint Source request for proposals on watershed management plan development. Requesting support of any kind from RRWC, especially as a 10% match, can include in-kind, is required. Grant is due Mar. 11, 2020. Suggestions about consultant company (Mannik and Smith).
