7. Outreach Coordinator Updates

- a. River Raisin Water Festival May 1, 2019: Didn't go as planned due to unforeseen circumstances, so only 1 school could be there, but was still a success with great positive feedback. Planning for next year begins soon.
- b. Advantage Visual Video Working with Drake Lolley (present) who will capture footage of events this summer and fall, then put together a 2-3 minute promotional video. Can create more/different videos with saved footage.
- c. Manchester/Bridgewater Twp/Sharon Twp RR Signage: Signs not posted yet. Sybil in touch with Jacob, one of the Eagle Scouts, who hoped to do it this summer.
- d. Vernal Pool Training Meeting with Sam from Hidden Lake Gardens to plan on creating a vernal pool volunteer group to monitor the pools on their property three times per year.
- e. Earth Day Bag Event Over 300 paper bags were decorated by Tecumseh Compass Learning Center $2^{nd} 4^{th}$ graders and handed out at Busch's in Tecumseh on Earth Day. The students decorated the bags to teach their community about plastic pollution and plastic alternatives.
- f. Chainsaw Training A couple of local RRWC volunteers and 8 employees from Washtenaw County Parks & Rec were able to join the 2 day session.

a. Working with Will Sadler from City of Adrian to collect samples at similar locations.
