- a. Cambridge Township Easement This item was addressed after approval of minutes due to schedules of interested attendees.
 - i. Kolon explained that the Raisin Valley Land Trust is dissolving and passing easements and assets on to Legacy Land Conservancy. An easement in Cambridge Township along a channel to Sand Lake does not meet the Legacy Land Conservancy qualifications, and therefore Raisin Valley Land Trust asks to have the River Raisin Watershed Council take on this easement. After discussion, motion by Bolton, second by Cooper to proceed with investigation on the transfer of the easement to RRWC pending attorney review of documents, with interest in acquiring it. Kolon abstained from the vote. MOTION CARRIED BY VOICE VOTE.
- b. Canoe and Kayak Race in Manchester
 - i. Kolon explained the difficulty the Manchester community is having with obtaining affordable insurance for the race, which RRWC has assisted with the past two years. RRWC is willing to assume sponsorship this coming year, in cooperation with community groups in Manchester who will continue to perform most of the duties. Kolon will assist with this effort and expects that funds will be raised to offset RRWC expenses.
